Pursuant to Arizona Revised Statutes §41-4603, I am sending you this Annual Reporting of Public Funding for Public Communications for the Maricopa County Attorney's Office (January 1, 2012 through December 31, 2012). As you know this legislation was passed in the second regular session of the 2010 Arizona Legislature and requires local governments to report to the Department of Administration all expenditures for communications that promote an individual elected official and that include the official's name or physical likeness.
